**WHO MUST FILE A DECLARATION IN GOOD FAITH—**(a) Every Bolivar resident who expects to receive taxable income, WHEREVER earned, which is not subject to withholding. Credit will be allowed, where due, for a similar income tax paid to other municipalities. (b) Every Non-Resident of Bolivar who expects to receive taxable income, earned or derived from within the Village, unless his entire Bolivar Village Income Tax is withheld by an employer. (c) Every Business entity, such as corporations, partnerships, unincorporated businesses, professional entities, or fiduciary of active trusts conducting activities or producing income within the Village of Bolivar.

**PENALTIES —** The income tax law imposes severe penalties for failure to file Declarations in good faith or pay quarterly payments when due, or make false or fraudulent ESTIMATES.

**DECLARATION MUST BE FILED —** on or before April 30, 19\_\_\_\_ except fiscal year taxpayers must file within 120 days following the end of their fiscal year. New taxpayers must file Declarations within 120 days of the date they became subject to the tax after July 1st, 1986, unless only one quarter is due.

**PAYMENT OF ESTIMATED TAX —** The amount due for 19\_\_\_\_ may be paid in full or in four equal installments. The estimated liability may be amended at the time of making any scheduled payment.

**ANNUAL TAX RETURNS —** Must be filed by all taxpayers after the close of their taxable year, based on actual taxable income and pay any balance due on or before April 30 of each year.
